Motion by Desslert, second by Peterson to approve a special temporary malt beverage license to Gary Rodeo Productions, Inc. AKA Gary Rodeo (Melvin & Tawnee Pieper) for July 6, 2019 & July 7, 2019 at Lots 1, Lewis Addition in E ¹/₂, SE ¹/₄, 4-115-47 & OL 14 in 4-115-47, Town of Gary. On Sale Only. All members voted aye, motion carried.

Verle Whipple from the American Legion was present to request funding towards the boys and girls summer ball program. These funds will help pay for tournament fees, insurance, umpires, supplies, etc. Motion by Dessler, second by Jenson to donate \$2,500.00 towards these expenses. Bekaert abstained and all remaining members voted aye, motion carried.

Plans are to meet at the City Park at 9:00 a.m. for anyone wishing to help. \$100 will be offered to local Church Youth Groups and the local 4-H Group if they would like to help with this clean up. Boulevard trees will again be available this year and must be ordered by April 27th. You can contact Mike Nosbush or the City Office if interested. Darwyn Engesser abstained with all remaining members voting aye, motion carried. In case of rain, the clean-up day would be held the following Saturday, May 4, 2019.

Anna Baumiller presented to the council her plans to re-plat the east 70 feet of her property at 415 2nd Avenue in order to park her Class A motor home on there during the summer months. Motion by Bekaert, second by Jenson to approve, motion carried.

Motion by Darwyn Engesser, second by Bekaert to approve the liquor store having a beer garden on the sidewalk in front of the bar for the street dance on July 3, 2019. A special temporary permit will need to be issued before that date. All members voted aye, motion carried.

Motion by Dessler, second by Peterson to upgrade the water meter reading system and software at a cost of \$11,202.00. All members voted aye, motion carried.

Motion by Darwyn Engesser, second by Kjelden to approve Mike attending the Spring Mosquito Workshop either in Aberdeen on the 24th of April or in Mitchell on April 25th. All members voted aye, motion carried.
