Mary Nosbush shared with the council that the annual meeting of the Gate City Development will be held at the fire hall community center on August 1st. Annual membership is \$25, lifetime membership is \$100.00. Membership fees must be received by July 20th.

A fund request was received from Deuel Area Development, Inc. but failed due to a lack of motion and second.

Motion by Dessler, second by Peterson to allow the 109 Club to be open on Wednesday, July 3 and on Sunday, July 7 for the holiday week. All members voted aye, motion carried.

Discussion was held on different areas around town where the streets need some repair. It was decided to ask for bids this fall for the work to be done next year.

A bid was received from Clark Equipment Company dba Bobcat Company, Government Sales for a new bobcat, snowblower, and grader with the old items being traded in. Motion by Bekaert, second by Jenson to go ahead with the purchase. All members voted aye, motion carried.

For safety reasons it was talked about replacing the swings at the City softball field. Kjelden will check into prices and bring them to a future meeting.

A building permit was issued in June to Anna Baumiller for a fence and a storage building on her property at 413 2nd Avenue.
