Council reviewed the sidewalk ordinance which states the property owner is responsible for replacing or repairing their own sidewalk. If the property owner wishes the city to replace the sidewalk it would be accessed to their taxes.

Motion by Jenson, second by Darwyn Engesser, to approve a special temporary liquor license for December 7 & 8 (until 1:00 a.m.), 2019 for the American Legion Ballroom (Matt Spilde) at E 23' of Lot 11 and all of Lots 12, 13, 14 in Block 1 of Original Plat, Gary, SD. On-sale only. All members voted aye, motion carried.

Motion by Dessler, second by Kjelden to advertise for bids for a 60' x 48' addition (just the shell) to the municipal liquor store. Specs will be written up and published in the Clear Lake Courier and will also be available at the city office. All members voted aye, motion carried.

Motion by Bekaert, second by Dessler to renew the annual contract with MinnKota Pest Services for preventative care in the amount of \$399.00. All members voted aye, motion carried.

Liquor operating agreements for the 109 Club and Buffalo Ridge Resort were reviewed. Motion by Dessler, second by Kjelden to leave the same as last year. All members voted aye, motion carried.

Leon Kaiser expressed his wish to restore the south gate to East Grandview Cemetery. Motion by Bekaert, second by Peterson to approve. All members voted aye, motion carried.

Motion by Kjelden, second by Darwyn Engesser to purchase a \$75 item for the auction during the NRA Banquet being held at the Gary Legion Hall on Saturday, October 19th. All members voted aye, motion carried.

The council reviewed the income and expenses for the golf course for 2019. The course is operating at a loss and the mower has only about a year of use left, but they decided to keep maintaining it and look at the numbers again next fall.

Motion by Darwyn Engesser, second by Dessler to provide Gary Bar t-shirts to the pool league that will be shooting out of the bar. All members voted aye, motion carried.

Motion by Bekaert, second by Jenson to approve Sally Winrow for a 3 year term on the Gary library board. All members voted aye, motion carried.

Building permits issued in September were to David Wyman for a 10 x 20 shed, Gary Grain Inc. to revamp building and repair the roof on the structure located at 1007 Coteau St., and Pat Sears for a sidewalk, dirt fill, and to plant trees.
