David Vogt was present to discuss de-annexing his property from the city limits again because he is receiving no city services. After much research between when this was first brought to the council and

Discussion was held on the 2021 BCBS health insurance renewal. Amber Peterreins is now the agent for the City of Gary. There was a decrease in the premium of 7.08% for 2021. Amber offered to do a cost comparison with other companies, but with the time line a motion was made by Kjelden, second by Dessler to stay with the current policy and possibly check other options next year. All members voted aye, motion carried.
