The second reading and adoption of Golf Cart Ordinance No. 2021-370 passed with a motion by Bekaert, second by Peterson. All members voted aye, motion carried.

Motion by Engesser, second by Gislason to approve the building plans as residential only in the purchase of land at the Gate City Development property. All members voted aye, motion carried.

There was discussion that a private party is interested in tiling the Golf Course at their expense, no action was taken at this time as that party was not present.

Motion by Engesser, second by Stee to approve the Mayor & Utilities Manager to use their discretion if needed to put a hold on resident's outdoor water usage. All members voted aye, motion carried.

Motion by Dessler, second by Engesser for reimbursement to managers for the use of their personal cell phone for job related business. With the possibility of the City purchasing a cell phone policy for the utilities manager. All members voted aye, motion carried.

Motion by Dessler, second by Stee to adopt a temporary ordinance regarding the issuance of local medical cannabis establishment permits and/or licenses. All members voted aye, motion carried. A public hearing and first reading will be held August 2, 2021
