Board of Adjustment member Nelson moved to approve the variance request second by Bekaert. Engesser opposed. Motion carried.

Motion by Nosbush, second by Engesser to adjourn as Board of Adjustment and convene as Gary City Council only. All members voted aye; motion carried.

A committee was formed to work on the 2024 appropriations prior to the readings. Motion by Stee, second by Bekaert to assign Doug & Larry to the committee. All members voted aye; motion carried.

Motion by Bekaert, second by Engesser to write a letter of proposal to Independent Audit Services, PC. Ben Elliott, CPA to complete the year ending 2022 audit. All members voted aye; motion carried.

The current website being used for garysd.com has had a substantial price increase. Other web hosts have been researched and a decision was made to hire local company Avid Hawk for \$950 to initially set up the site and \$49 monthly charge with a motion by Nelson, second by Stee. All members voted aye; motion carried.

More discussion on updating the Comprehensive Land Use Plan and Zoning Ordinance was heard and approved. Motion by Bekaert, second by Stee to hire First District Association of Local Governments to assist in the process of updating the material, for a cost not to exceed \$6,000. All members voted aye; motion carried.

Motion by Engesser, second by Stee to declare the following as surplus. 2 office chairs, Christmas lights, sander, 9 toilet paper & 7 paper towel dispensers, 100 cup coffee maker, 4 basketball hoops. All members voted aye; motion carried. If you are interested in purchasing the basketball hoops, please contact City Hall.

Jay Grabow was appointed by Nosbush, second by Engesser to fill the vacant chair in Ward 2 until the next annual election. All members voted aye; motion carried. Oath of Office was read.

Rick Christians, Talking Waters Campground & Will Stone, Stone's Gate City Lodge were present to ask about the base rates for their businesses. After a lengthy discussion no changes will be made to the rates.

Cory Borg gave an update that the Gary Fire Dept Ambulance has been licensed and passed inspection by the State of SD. He asked for funds to finalize the initial set up of supplies and if the equipment can be added to the insurance policy. Motion by Nelson, second by Nosbush to give \$5,000 now and be presented a financial statement annually, along with adding the Ambulance and certain equipment to the insurance policy. All members voted aye; motion carried.

Information will be gathered and brought to the next meeting about letting the Community Club house a storage shed on City property.

Two written complaints related to dogs were filed and discussed. Letters and Ordinance information will be sent to the property owners.

The 2021 Audit was reviewed with the suggestions of adding cameras to the City Hall for security and adopting a Fraud Policy. The Finance Officer will check into pricing for cameras. Motion by Nosbush, second by Bekaert to approve and add the Fraud Policy to the Personnel Policy Handbook. All members voted aye; motion carried.

A request for a special temporary liquor permit for the American Legion Post 109 Dance Hall at E 24' of Lot 11 and all of Lots 12,13,14 in Block 1, Original Plat, City of Gary, South Dakota for July 15th, August 5th & 12th, 2023. On sale only until 1am. Motion by Stee, second by Engesser to issue the permit. All members voted aye; motion carried.
