RESOLUTION REGARDING A STREET AND INFRASTRUCTURE AGREEMENT WITH DAKOTA WIND EXCHANGE, LLC WITHIN THE CITY OF GARY

WHEREAS the City of Gary, has entered into an agreement with DAKOTA WIND EXCHANGE, LLC for street, water, and sewer infrastructure improvements, and

WHEREAS the costs of construction of the project will be borne by DAKOTA WIND EXCHANGE, LLC; and

WHEREAS this project is a public improvement, which will directly benefit or potentially benefit the property adjacent to which the improvements are constructed; and

WHEREAS the construction of this public improvement will not result in any direct benefit inuring to the City; and

NOW, THEREFORE, BE IT RESOLVED by the City of Gary, as follows:

- 1. The City authorizes the agreement with DAKOTA WIND EXCHANGE, LLC, dated the 2nd day of October, 2023.
- 2. DAKOTA WIND EXCHANGE, LLC is responsible for the costs related to the project and the City will incur no costs related to the Project; and,
- 3. For each individual lot connecting to any and all future connection to the water and sewer improvements made by DAKOT WIND EXCHANGE, LLC, a \$5,000 fee will be collected.
- 4. Upon collection of the fee, the City will reimburse DAKOTA WIND EXCHANGE, LLC for each \$5,000 fee collected.

Mel & Keith Borg have installed an irrigation system at their 1.5 acres and addressed the Council about paying for water and eliminate the sewer charge. A separate water meter would make this possible for watering only.

A decision was made to allow this with the resident paying for another meter, all the installation costs and having the City approve it before an account is open to be charged the monthly flat rate, residential water rate and to not include the sewer charge. Angel Oeltjenbruns with the Gate City Development informed the council on grant possibilities through the South Dakota Governor's Office of Economic Development. Motion by Nosbush, second by Grabow to support the GCDA in applying for a planning grant to begin a survey for childcare needs. All voting aye; motion carried.

Motion by Grabow, second by Nelson to form a committee of Engesser, Nosbush and Grabow to discuss funding options for the state water plan application and bring their information to a future council meeting. All voting aye; motion carried.

Discussion about replacing the polycap on the fence at First Ave ballfield will be held again at another meeting.

Motion by Nosbush, second by Bekaert to attempt in collecting the cost of the city mowing abandoned property by sending a letter along with a bill to the property owner. If not paid by a certain date, the cost of mowing will be sent to the County Auditor and assessed to the individual's taxes. This motion adopts the following resolution which addresses this special assessment:
